Zestawienie obcojęzycznych źródeł informacji

Opracowane zestawienie źródeł informacji obejmuje wybrane wyniki wyszukiwań tematycznych, prowadzonych w międzynarodowych bazach elektronicznych zasobów informacyjnych, udostępnianych w ramach tzw. licencji krajowych (Wirtualna Biblioteka Nauki – WBN) oraz w bazach, subskrybowanych przez Instytut (ProQuest, IEEE/IET, OSH-UPDATE), a także w innych źródłach, dostępnych w sieci Internet.

Zasoby wymienione w zestawieniu są dostępne w CIOP-PIB (m.in. w Czytelni Instytutu, dostęp ze strony internetowej Biblioteki: www.ciop.pl/biblioteka), a także w wielu innych jednostkach naukowych, badawczo-rozwojowych, korzystających z dostępu do światowych zasobów wiedzy. Znaczna część wyszukanych pozycji piśmiennictwa dostępna jest na zasadzie tzw. otwartego dostępu. W trakcie wyszukiwań korzystano m.in. z multiwyszukiwarki zasobów naukowych, integrującej w znacznym stopniu zasoby dostępne w Instytucie.

Wykorzystywane wyrażenia wyszukiwawcze obejmowały problematykę pracy zdalnej w aspekcie bezpieczeństwa pracy. Były to takie frazy, jak m.in.: *remote work*, *telework*, *telecommuting* (AND *occupational hazard*). Wyniki wyszukiwań zawężano do recenzowanych zasobów informacyjnych (przede wszystkim artykułów naukowych z obcojęzycznych czasopism), obejmujących publikacje z lat 2020-2022.
